## ANNEXURE - I

General Conditions

1. The College should strictly adhere to the eligibility conditions prescribed by the University / Government in admitting candidates for the courses offered and also to the said courses.
2. The College should not admit students over and above the strength sanctioned by the University.
3. No amount should be collected from the students in excess of the fees prescribed by the University / Government or donations for appointment of persons for both teaching and non-teaching positions.
4. College should adhere to the Tamil Nadu Government Reservation Policy in admitting candidates and appointment of staff.
5. There shall be no financial commitment on the part of the State Government or University on account of the courses being started by the college.
6. The College should pay salary to the teachers as prescribed by the Government / UGC.
7. The College should provide space and facilities to the University to conduct examinations and for other academic purposes as and when required.
8. The Course noted above has only be granted as Self Financing Course.
9. The students shall be permitted to appear for the First Semester Examination only after 90 working days from the date of receipt of this affiliation order.
10. The management should get the continuance of affiliation for the above said courses every year.
11. The management should obtain the approval from the University for the appointment of teaching staff.
12. The management should select the Optional / Ancillary Subject for the above courses in consultation with the Controller of Examinations of the University.
13. Approved Syllabus can be had from the Board of Studies Section of this University.

## ANNEXURE - II

Specific Conditions

1. The management should construct a separate block for II and I year students of BCA before May 2003.
2. The management should purchase some more recent books for Computer Science students.
3. The management should appoint teaching staff for B.C.A. Degree Course immediately.

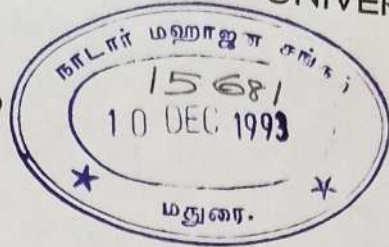

7. The students shall take First Semester in April 1994 and Second and Third Semesters in November 1994 for this batch only, <sup>making good the attendance.</sup>
